On January 31, 1990, Robles and two other inmates were caught while allegedly attempting to escape from the detention facility. While in custody and awaiting trial for the alleged escape attempt, on April 3, 1990, Robles successfully escaped with seven other inmates from the detention facility in San Diego. His whereabouts remain unknown.

On April 15, 2003, a federal arrest warrant for Arturo Robles was issued in the Southern District of California, charging Robles with unlawful flight to avoid confinement.
